- 3.3. Concealment of facts / misinformation will be sufficient cause for disqualification.
- 3.4. Any cutting over writing must be authenticated by the authorized person.
- 3.5. The KSSL reserves the right to disqualify a company as per Rule 18 of the PPRA Rules 2004.
- 3.6. Relevant evidences are to be attached.
- 3.7. Incomplete / conditional applications will not be considered.
